Sub :- Posting as Air Customs Superintendents to Cochin International Airport,
Nedumbasseri against 25% quota for Central Excise Commissionerates – Reg.

The following Superintendents of Central Excise are hereby posted to Cochin International Airport, Nedumbassery for a period of two years with immediate effect.

2 The terms & conditions for selection and posting at Cochin International Airport, Nedumbassery as Air Customs Superintendent are as follows:

- The officers posted at the Airport will be eligible to draw pay and allowances at the same rates admissible to them from time to time.
- They shall be considered as on deputation to the Airport, but no deputation allowance will be admissible to them.
- Normally, the period of deputation at the Airport is two years. However an officer at the Airport can be reverted before completion of two years without assigning any reason.
- The officers posted at the Airport will have to make their own arrangement for residential accommodation.
- The officers will also be entitled to draw uniform and diet allowance as admissible under rules.
- In the event of their promotion to the higher grade, the officer will be liable to be reverted to their parent Commissionerate or posted anywhere as may be ordered by the competent authority in this regard.
- They should join the new place of posting immediately failing which the posting order will be treated as cancelled.
